# **Course Description and Purpose**

Macroeconomics is a highly practical discipline as it deals with principles that directly impact every part of life. They affect employment, government welfare, the availability of

goods and services, the way nations interact with one another, the price of food in the shops etc. The knowledge gained in this course will make students better informed citizens and allow them to follow the debates over national economic policy reported in the news media. This course is also, a foundation course that will prepare students to be successful in upper division finance, marketing, business administration, economics, government, and social work courses.

## **Course Goals**

Upon successful completion of the course, you should be able to:

- Explain the role of scarcity, specialization, and cost-benefit analysis in economic decision making.
- Analyze how buyers and sellers interact in a free and competitive market to determine prices and quantities of a good.
- Identify the determinants of supply and demand; demonstrate the impact of shifts in supply and demand curves on equilibrium price and output.
- Define and measure Gross Domestic Product and national income, and rates of unemployment and inflation.
- Describe and analyze the sources of economic growth.
- Explain Keynesian economics using the Income- Expenditure Model.
- Construct the aggregate demand and aggregate supply model of the macro economy and use it to illustrate macroeconomic problems and potential monetary and fiscal policy solutions.
- Define money and the money supply; describe the process of money creation by the banking system and the role of the central bank.

# **Expectations of the Course**

## **Attendance Policy**

## Grading Policy

I reserve the right to curve the scale dependent on overall class scores at the end of the semester. Any curve will only ever make it easier to obtain a higher letter grade. Incomplete will be given only under exceptional circumstances. Any kind of emergency must be documented to receive an "Incomplete". Doing poorly in the course will not be considered a valid reason. The grade will be calculated using the following proportions:

- 15% of your grade will be determined by in class midterm exam 1
- •15% of your grade will be determined by in class midterm exam 2
- 30% of your grade will be determined by the final exam
- 20% of your grade will be determined by homework
- 20% of your grade will be determined by group discussions

Final Grade = (Midterm 1 \* 0.15) + (Midterm 2 \* 0.15) + (Final Exam \* 0.30) + (Homework Average \* 0.20) + (Group discussion \*0.20)

If your final exam is a higher score than any of your three previous exams them your final grade will be calculated as follows (**Resurrection grade policy**):

Final Grade = (Average of Final Exam and midterm Exam (Higher) Scores \* 0.30) + (Homework Average \* 0.20) + (group discussion \*0.20) + (Final Exam \* 0.30)

Students will be able to:

- Use tables and graphs to illustrate market equilibrium.
- Use Demand and Supply graphs to predict changes in prices and quantities.
- Show how shifts in either supply or demand change equilibrium outcomes
- Define Technology and provide examples of technological change.
- Distinguish between the Short Run and Long Run in economics.
- Explain the relationship between production and costs.
- Explain and illustrate the relationship between the Marginal and Average Product of Labor, as well as the relationship between marginal cost and average total cost.
- Graph and interpret the average total cost, average variable cost, and marginal cost.
- Explain the Long Run Average Cost Curve, and how firms use it in their planning.
- Explain what a perfectly competitive market is and why firms in this market face a horizontal demand curve.
- Explain the process of profit-maximization in a perfectly competitive market, and be able to use graphs to show a firm's profit or loss.
- Explain how perfect competition can lead to economic efficiency.
- Explain why monopolistically competitive firms have a downward-sloping demand and marginal revenue curves.

- Explain the process of profit-maximization in a monopolistically competitive market, and be able to use graphs to show a firm's profit or loss in the short-run.
- Compare and contrast the efficiency of monopolistic competition and perfect competition.
- Explain the characteristics of an oligopolistic market, and show how barriers to entry explain the existence of oligopolies.
- Use basic Game Theory to analyze the strategies of oligopolistic firms.
- Describe Michael Porter's Five Competitive Forces Model to analyze competition in an industry.
- Describe monopoly, and explain the main reasons monopolies arise.
- Explain how monopoly firms choose price and output.
- Use a graph to illustrate how monopoly affects economic efficiency.
- Explain how a firm can increase its profits through Price Discrimination.
- Explain how the government regulates monopoly.
- Explain the Antitrust Laws and their purpose.
