Course Description and Purpose

This course is designed to provide students with a deeper understanding of microeconomic principles and concepts using calculus as a tool. Building upon the foundation of introductory microeconomics, the course delves into more advanced topics and models that are crucial for analyzing individual consumer and producer behavior, market equilibrium, and the impacts of various economic policies. Applications include the economics of insurance, education, health care, pollution, taxation, safety, and other topics.

Course Goals

- To extend students' understanding of microeconomic theory beyond the basics.
- To equip students with the skills to use calculus as a tool for solving more complex microeconomic problems.
- To enable students to analyze and evaluate real-world economic scenarios and policy implications.
- To enhance students' ability to think critically and apply economic reasoning to various situations.

be applied to that exam. **There will not be any make-up exams or rescheduling of exams.**

Exams are **not** open book. The exams will be proctored through the virtual proctoring service.
